1. CALL TO ORDER

Members not present were Jason Needham, Garhett Gordon and Matt Poston having given prior notice of their absence.

2. INVOCATION AND PLEDGE OF ALLEGIANCE

Invocation was given by President Nick Stanley and the Pledge was given by all present.

3. APPROVAL OF MINUTES

Motion was made by Director Spencer Perry, seconded by Director Ryan Merrill to approve the minutes from the regular meeting, May 18, 2023, Special Joint meeting from June 2, 2023 and the Special meeting from July 20, 2023 as read.

4. OTHER BUSINESS

A. Discussion and action to consider approval of the proposed FY24 Budget.

City Manager Noah Simon addressed the Board regarding the Proposed FY 24 Budget. He stated that we are not using EDC Funds for Capital projects this year. We moved 100% of the events into the EDC Fund and moved staff salaries to the General fund budget. The sales tax reflects the abatements approved for Jakes Burgers, Press Café and Dayne's BBQ. We will be taking an RFP to the Council next week for removal of the Train Depot from the City Hall site. There are utilities that are sitting under the Depot that are needed for the construction of City Hall. The Depot will be moved and then restored. In the RFP it is stated that the Depot must remain in the City limits of Aledo. A local group is interested in moving it.

We are proposing for an Ice Rink to be set up seasonally at the Aledo Commons Parking Lot. From about November 20th through the month of December. The Ticket Sales will generate around \$200,000 in income. To rent it will be around \$170,00 There would be an additional income of \$30,000.00.

Following discussion, motion was made by Director Spencer Perry, seconded by Director Ryan Merill to approve the FY24 Proposed Budget.

Motion carried 5-0

B. Discussion regarding Economic Development Incentives.

City Manager Noah Simon talked with the Board in reference to future Economic Development Incentives. We cannot incentivise every restaurant or business that wants to come in. It would be looked at and discussed on a case by case basis. He wanted the Board to come with topics for EDC Incentives to discuss at future meetings. Wayst to help the existing businesses and to attract new small businesses. Ways to be proactive.

There was discussion but no action on this item.
