Executive Session:

Mayor Kit Marshall adjourned the Special meeting of the Aledo City Council into Executive Session at 6:02 p.m. to discuss the below listed items. Those in attendance of this Executive Session were: Mayor Kit Marshall, Mayor Pro Tem Dan Herbert, Councilmember Nick Stanley, Councilmember Shane Davis, Councilmember Kimberly Hiebert, Director of Public Works Gretchen Vazquez, Interim City Administrator Sharon Hayes, City Secretary Deana McMullen, City Attorney Alicia Kreh, Mary Petty, Jason Huges and Erick Macha.

Pursuant to the Texas Open Meetings Act, Chapter 551 of the Texas Government Code, the City Council may convene in executive session to deliberate regarding the following matters:

3. Discussion and/or action to receive Council input on development policies for the Dean Ranch Development.

Mayor Kit Marshall adjourned the Executive Session of the Aledo City Council at 7:15 p.m. and reconvened the Special Meeting at 7:16 p.m.

Ms. Stacy Lynch of Stacy Lynch Real Estate in Willow Park addressed the Council to say that they have been working with Mr. Ben Clark and DR Horton Homes for the Dean Ranch Development and their new partner Richard Levens. This development will bring over 400 residential lots with selling prices starting at \$500,000 plus 112 acres of Commercial Development. This will net the City of Aledo approximately \$220 million to \$270 million dollars in income. Ms. Lynch stated that this was a Huge Gift and thanked Mr. Ben Clark and DR Horton homes for coming to Aledo.

There was no motion by the Aledo City Council on this item. Mayor Marshall stated that the consultants will move forward on the items discussed in Executive Session and come back to the City Council for another Special meeting on Wednesday, May 18, 2022 for further consideration.

There being nothing further to discuss or consider, Mayor Kit Marshall adjourned this Special meeting of the Aledo City Council at 7:20 p.m.
