#### STAFF REPORTS

City Administrator Sharon Hayes asked Council if they preferred to receive calendar invites and Council agreed they would be helpful. Sharon introduced City of Aledo's new City Planner, Nathan Gonzales, and stated that she is excited for what Nathan brings to Aledo. Staff has hired an Assistant Public Works Director, Christian, who will begin in February 2022. Sharon reported that City of Aledo's Building Official, Randy Law, will be leaving the City and his last day is January 31, 2022. Bureau Veritas will complete inspections until the position is filled. She will provide the contract at next month's City Council meeting. The broadband project has begun, and Todd Covington will discuss further. The utility department will begin looking at

automated metering. The decorative streetlights have been restored with LED lights. NEIGHBORHOOD SERVICES ZONE WILL BE PRESENTED IN MARCH 2022 AT THE P&Z MEETING. P&Z AND P&R ORDIANCES TO HAVE AN ALTERNATE AND ALLOW THE BOARD TO CHOOSE THEIR APPOINTED CHAIR RATHER THAN COUNCIL. LOOKING AT THE FOOD TRUCK ORDINANCE.

Covington Services representative, Todd Covington, reported to review the marketplace and provided a temporary solution for the broadband issue. The projected length of this project is 2-4 years.

Director of Parks and Events, Erica Haney, reported that Bearcat Park will begin demolition on Monday, January 31<sup>st</sup>. As soon as demo is complete the playground installation will take place depending on the weather. The playground at the Community Center is also under renovation as the swings are being painted. The skills trails have also kicked off and will be looking to relocate the dumpster in the parking lot.

Director of Public Works, Gretchen Vasquez, reported that the Bailey Ranch Reconstruction project will begin on February 18, 2022. AISD will be out of school and expect to make great progress during the closure. During the reconstruction the flow of traffic will be 2 way and take 9 phases to complete. The reconstruction project will be posted on social media and on City webpage.
