# **CALL MEETING TO ORDER**

Mayor Nick Stanley called the regular meeting of the City Council to order at 6:04 pm on Thursday, June 24, 2022. Those in attendance at this meeting were Mayor Nick Stanley, Councilmember Christian Pearson, Mayor Pro Tem Shane Davis and Councilmember Dan Herbert. Councilmember Nelson Rowls was not in attendance at this meeting having given prior notice of his absence.

Staff present were City Manager Noah Simon, Director of Parks and Events Erica Haney, Director of Public Works Gretchen Vazquez, City Planner Nathan Gonzales, City Secretary Deana McMullen and City Attorney Lindsey Hale.

# **ITEMS FOR DISCUSSION:**

1. Public Hearing to consider and receive input regarding consideration of a request for a Zoning Change from (R-2) Single Family Residential District to (PD R-2) Planned Development Single Family Residential District – Lots 8-9, Block 9, Lasater Addition, an addition to the City of Aledo, Parker County, Texas, according to the plat recorded in Volume 277, Page 641, Plat Records, Parker County, Texas.

Mayor Nick Stanley opened the Public Hearing at 7:01 p.m to consider and receive input for or against the request for a Zoning Change from (R-2) Single Family Residential District to (PD R-2) Planned Development Single Family Residential District – Lots 8-9, Block 9, Lasater Addition, an addition to the City of Aledo, Parker County, Texas, according to the plat recorded in Volume 277, Page 641, Plat Records, Parker County, Texas. Mayor Nick Stanley stated that the applicants for this Zoning Change request are asking for the Council to waive the 45 day requirement that is in the City of Aledo Zoning Ordinance and table this item until the next meeting and have an opportunity to meet with the residents in the area.

Mayor Nick Stanley invited the citizens that signed in with a request to appear before the City Council to come up one at a time to speak.

- 1) Susan Houghtalin -315 Plum St. Ms. Houghtalin spoke to the council and stated that the owners had not spoken to any of the residents in the area as of this date. The P&Z Board unanimously voted against this request to change the lot sizes. She also mentioned that the Lasater addition has convenants agains changing lot sizes that goes back to 1955. She gave the City Secretary a petition that was signed by the residents in the Lasater addition that were against the Zoning change request.
- 2) Maryann Godbey 200 Robert Street Stated that she has lived in this neighborhood for over 20 years because of the neighborhood. She does not want or need to be in a crowded

neighborhood like the new developments are. She asked the Council to take up for the residents that are against this change.

3) Stanton Pearson – 605 Shary St- Have lived in this neighborhood for 11 years. We know change is coming. We know about the Pine Street Project and have concerns about people blocking our driveways and us being able to let our children ride their bicycles in the neighborhood. There should be stop signs at every intersection to slow people down. I served on the Home Rule Charter Committee because I am proud of Aledo. Mayola Lasater was proud of Aledo and she put the convenants in place in the Lasater addition for a reason. We were here a year and half ago fighting the same thing. We do not want this change in our neighborhood.

Mayor Nick Stanley stated that the Council hears what everyone is saying. The City Council and the Boards and Commissions are required to hear zoning changes when developers request them. All of your concerns will be considered. Thank you for being here.

Mayor Nick Stanley closed the Public Hearing at 7:17 pm

2. Discussion and action to consider approval of request for a Zoning Change from (R-2) Single Family Residential District to (PD R-2) Planned Development Single Family Residential District – Lots 8-9, Block 9, Lasater Addition, an addition to the City of Aledo, Parker County, Texas, according to the plat recorded in Volume 277, Page 641, Plat Records, Parker County, Texas.
