They can be Guest Homes, Mother-In-Law Quarters, Pool houses, but this type of dwelling is becoming popular and should be considered.

Mr. Gonzalez went over several catagories of items to talk about.

One is to Simplify the Code making it easier for developers to understand exactly what the City wants.

The second is it must be effective. Thirdly it should describe the Context and lastley it should be easy for the Administrative Staff to work with.

There was no action on anything discussed. This is a informational meeting for the City Council and Planning & Zoning to give their thoughts and ideas. The final document will be brought back to both the Planning and Zoning as well as the City Council for approval once it is finished. There will be additional Joint meetings for further discussion in the neae future.
