#### **CALL TO ORDER**

The Aledo City Council met in regular session on April 27, 2017, at the Aledo Community Center, 104 Robinson Court, Aledo, TX 76008. Mayor Kit Marshall called the meeting to order at 7:02 p.m. with the following members present; Councilmember Kerby Smith; Councilmember Jean Bailey, Councilmember Daniel Herbert and Councilmember Bob Wood. Mayor Pro Tem Kimberly Hiebert was not present having given prior notice of her absence.

Proclamation recognizing May as Motorcycle Awareness month

Mr. Sam James – Deacon of the Aledo Church of Christ came before the Council to discuss the historical paint shack. Mr. James stated that the paint shack has a long history in Aledo and for many years citizens have painted messages on the shack. The Aledo Church of Christ is ready to pass the Baton to someone else and have the paint shack removed from their parking lot. Many who paint messages on the shack leave a mess behind, paint on the parking lot and use the rail fence to clean brushes causing the Church to spend a lot of money to clean it up. Mayor Marshall thanked Mr. James for being here tonight and thanked the Church of Christ for allowing the paint shack to be on their property and for them embracing the history and challenges.

### 7. Discuss and action concerning approval of the annual financial audit – October 1, 2015 to September 30, 2016.

Mike Vail, CPA was present to discuss the Annual Financial Audit –October 1, 2015 to September 30, 2016. Mr. Vail said that the City of Aledo has a clean audit and found no instances of non-compliance that are required to be reported under Government Auditing Standards.

Following the presentation motion was made by Councilmember Kerby Smith seconded by Councilmember Jean Bailey to approve the audit as presented.

### 8. Discussion and action regarding award of the contract for the FY 2017 Street Improvement Project.

Director of Public Works David Fain gave information to the Council regarding the award of the contract for the FY 2017 Street Improvement Project. Mr. Fain said that bids were opened on April 13, 2017 and a total of 12 bids were received. The City budgeted \$318,000 for street improvements in the 2017 budget and have targeted Plum/Robert/and John Streets. The low bid for this project was for \$178,890 by Advanced Paving.

Motion was made by Councilmember Jean Bailey, seconded by Kerby Smith to approve and award the bid to Advanced Paving for street repairs on Plum/Robert/and John streets in the amount of \$178,890.

City Administrator Ken Pfeifer reported to Council that the sidewalk bids would be let next week and the 3<sup>rd</sup> grant for sidewalks from City Hall down Old Annetta to the west city limits should be approved soon. We are expecting significant movement on the new Medical Office Building soon. TXDOT has reported that the bridge at I20-FM1187 is expected to be completed within

the next 3 weeks.

City Secretary Deana McMullen reported on Special event First Friday to be held on Friday, June 2, 2017 from 6-9 pm in the downtown Aledo.

The top on the Veterans Plaza Monument should be placed tomorrow morning.

Director of Public Works David Fain reported that building permits were on target to meet or exceed last years numbers.
