The Aledo City Council met in special session on September 7, 2017, at the Aledo Community Center, 104 Robinson Court, Aledo, TX 76008. PROCLAMATIONS

Proclamation recognizing September as Preparedness month in the City of Aledo

Mayor Kit Marshall presented the Proclamation recognizing September as Preparedness Month in the City of Aledo to the City Council.

ITEMS FOR DISCUSSION:

1. Public Hearing – Discussion on Proposed Fiscal Year 2017-2018 Budget and to consider ad valorem tax rate of \$0.3850 per \$100 valuation for the 2017-2018 fiscal year, which rate would increase total tax revenue by 22.5944% from properties on the tax roll in the preceding year.
