Motion was made by Councilmember Jean Bailey seconded by Mayor Pro Tem Kimberly Hiebert to approve the ordinance number 2017-088 that renames a portion of Old Annetta Road to South Front Street as presented and if the original town of Aledo plat shows the road in question as South Front, then amend the ordinance to reflect the clarification of the intent. Motion carried 3-0
