# CITY OF ALEDO, TEXAS CITY COUNCIL MINUTES MEETING LOCATION: ALEDO COMMUNITY CENTER 104 ROBINSON COURT ALEDO, TEXAS 76008 THURSDAY, MARCH 26, 2015 7:00 P.M.

#### **CALL TO ORDER**

The Aledo City Council met in regular session on Thursday, March 26, 2015, at the Aledo Community Center, 104 Robinson Court, Aledo TX 76008. Mayor Kit Marshall called the meeting to order at 7:03 p.m. with the following members present: Councilmember Jean Bailey, Mayor Pro Tem Bill McLeRoy, Councilmember Kerby Smith and Councilmember Matt Casey. Councilmember Kimberly Hiebert was not present at this meeting having given prior notice of her absence.

Staff members present at the meeting were: City Administrator Ken Pfeifer, City Secretary Deana McMullen, Director of Public Works David Fain, Accounting Coordinator Kari Kszyminski and City Attorney Drew Larkin.

#### INVOCATION AND PLEDGE OF ALLEGIANCE

Knox Ross of Aledo Christian Center gave the Invocation. Mayor Pro Tem Bill McLeRoy led the Pledge of Allegiance.

#### **PROCLAMATIONS**

Proclamation recognizing Aledo High School Football Team for State Championship Win

Mayor Kit Marshall read the Proclamation recognizing Aledo High School Football Team for their State Championship Win and presented the Proclamation to Head Coach Steve Wood.

3. Approval of contract with Pyro Shows of Texas for Community Fireworks Display on June 5, 2015.

Mr. Janson Stanley of Pyro Shows of Texas was present to answer any questions regarding the contract for the Community Fireworks Display for the First Friday event on June 5, 2015. Following discussions with the city attorney's office Mr. Stanley stated the Pyro Shows of Texas was ok with the changes made in the contract, but there were a few more details to work out particularly the section regarding reschedule/cancellation (rain date).

Motion was made by Councilmember Kerby Smith, seconded by Councilmember Jean Bailey to approve the contract with Pyro Shows of Texas and authorize Mayor Kit Marshall to sign the contract once it has been approved by the City Attorney.

Mike Vail of Vail & Knauth, presented the annual financial audit to the City Council for the fiscal year ending September 30, 2014. The City of Aledo has a healthy financial situation and Reserves have increased in all funds. Following his presentation Mr. Vail answered questions from the City Council.

Following discussion, motion was made by Councilmember Matt Casey, seconded by Councilmember Jean Bailey to approve the financial audit for the fiscal year ending September 30, 2014 as presented.

City Administrator Ken Pfeifer reported to the Council that we had the final inspection for the Quiet Zone on March 18, 2015. It will be 21 days before the trains stop blowing the horns. We plan a Celebration for this milestone in 1 to 2 weeks to allow the engineers the time to adjust to no longer blowing the horn. Mayor Marshall stated that this was a Benchmark for the City of Aledo and it is important to remember the significance and importance of this and what it means for the quality of life and public safety in the City of Aledo.

City Administrator Ken Pfeifer also reported to the Council regarding the mowing on FM 1187 particularly north of Bankhead. Even though this is outside the city limits of Aledo, it is the entrance to Aledo and we want it to look nice. TXDOT has informed us that we will have to do the mowing on the medians and right of ways. This is not terribly expensive and for economic growth it is important to keep the areas in question manicured.

Director of Public Works David Fain reported that the fencing on Elm Street Park was moving along and we would follow the Parks Master Plan for this park. Also the Community Center Park Pavilion was moving along and we should have plans and specifications for the May Council meeting. Aledo Trail is now listed as substantially complete.

Mayor Kit Marshall stated that she is planning a trip with the East Parker County Chamber to Austin to testify before the Legislature.
