#### **CALL TO ORDER:**

The Aledo City Council met in special session on Thursday, September 3, 2015, at the Aledo Community Center, 104 Robinson Court, Aledo, TX 76008. Mayor Kit Marshall called the meeting to order at 7:26 p.m. with the following members present: Councilmember Jean Bailey, Mayor Pro Tem Kimberly Hiebert and Councilmember Bob Wood. Councilmember Kerby Smith and Councilmember Paula Johns were not present at this special meeting having given prior notice of their absence.

Staff members present at the meeting were: City Administrator Ken Pfeifer and City Secretary Deana McMullen.

### INVOCATION AND PLEDGE OF ALLEGIANCE

Mayor Kit Marshall gave the Invocation. Councilmember Bob Wood led the Pledge of Allegiance.

#### **PUBLIC HEARING:**

1. Discussion on Proposed Fiscal Year 2015-2016 Budget and To consider a proposed ad valorem tax rate of \$0.3850 per \$100 of valuation for the 2015- 2016 Fiscal Year, which rate would increase total tax revenue by 0.169967% from properties on the tax roll in the preceding year.

Mayor Kit Marshall opened the Public Hearing at 7:27 pm to receive input from anyone wishing to speak for or against the Proposed 2015-2016 Fiscal Year Budget and the proposed Ad Valorem Tax rate of \$0.3850 per \$100 valuation.

There was no one present to speak on this item. Mayor Kit Marshall then closed the Public Hearing at 7:28 p.m.

City Administrator Ken Pfeifer informed the Council that the changes that were discussed at the first public hearing held on August 27, 2015 were added to the proposed budget. They were monies for street repairs to Holt Lane, monies for the match amount for the Outdoor Warning System and monies for the Salary increase. Staff answered questions and there was no action

taken on this item. The Budget and Tax rate adoption is scheduled for the September 17, 2015 Agenda.
