### CALL TO ORDER

The Aledo City Council met in regular session on Thursday, September 17, 2015, at the Aledo Community Center, 104 Robinson Court, Aledo, TX 76008. Mayor Kit Marshall called the meeting to order at 7:30 p.m. with the following members present: Councilmember Jean Bailey, Mayor Pro Tem Kimberly Hiebert, Councilmember Paula Johns and Councilmember Bob Wood. Councilmember Kerby Smith was not present at this regular meeting having given prior notice of his absence.

Staff members present at the meeting were: City Administrator Ken Pfeifer and City Secretary Deana McMullen, Director of Public Works David Fain, Accounting Coordinator Kari Kszyminski and City Attorney Betsy Elam.

### INVOCATION AND PLEDGE OF ALLEGIANCE

Invocation was given by Mayor Kit Marshall. Councilmember Bob Wood led the Pledge of Allegiance.

Mayor Kit Marshall read aloud a Proclamation Proclaiming September 17, 2015 as North Texas Giving Day.

### **ITEMS FOR DISCUSSION:**

1. Discussion and action concerning approval of an Ordinance adopting the Fiscal Year 2015-2016 annual budget.

Motion was made by Councilmember Paula Johns seconded by Councilmember Jean Bailey to approve the Ordinance that adopts the Fiscal Year 2015-2016 annual budget.

Motion carried 4-0 with Councilmember Jean Bailey, Councilmember Bob Wood, Mayor Pro Tem Kimberly Hiebert and Councilmember Paula Johns voting in favor of the motion. Mayor Kit Marshall does not vote except in the case of a tie vote.

# 2. Discussion and action to ratify the property tax revenue increase reflected in the Fiscal Year 2015-2016 annual budget.

Motion was made by Councilmember Jean Bailey seconded by Councilmember Paula Johns to ratify the property tax revenue increase reflected in the Fiscal Year 2015-2016 annual budget.

Motion carried 4-0

## 3. Discussion and action concerning approval of an Ordinance setting the Ad Valorem Tax Rate of \$0.3850 per \$100 taxable value for Fiscal Year 2015-2016.

Councilmember Jean Bailey made a motion, seconded by Mayor Pro Tem Kim Hiebert that the property tax rate be increased by the adoption of a tax rate of \$0.3850 per \$100 taxable value which is effectively an 8.14% increase in the tax rate.

(the property tax revenue has increased due to assessed valuation increases and new construction)

Motion carried 4-0

Bailey as referenced in Volume 1161, page 505, Volume 279, Page 416, Deed Records of Parker County, Texas.

- **8. Public Hearing** the purpose of said public hearing is to receive input regarding approval of an ordinance to amend the Thoroughfare Plan recognizing the realignment of Bailey Ranch Road and Jenkins Road.

Mayor Kit Marshall opened the Public Hearings for items 4 thru 8 at 7:39 pm for anyone wishing to speak for or against any of the items regarding the Concept Plan/Future Land Use Plan/or Zoning change requests for the proposed development, Parks of Aledo Point Vista.

Fred Disney and Justin Welborn were in attendance to give a presentation regarding the proposed development Parks of Aledo Point Vista. This will be a 132 acre Planned Development with 266 proposed lots with 45% open space and 65% of the lots will be adjacent to the open space. There will be 70 lots in the first phase. This development will have a specialized trail system that will be approximately 4 ½ miles, a community garden, a dog park, Frisbee golf and Shade structures as well as a 20' pedestrian walkway.

The Concept Plan is almost identical to the Parks of Aledo with the exception of the siding/masonry. The existing plan is 100% except over roof lines. We can change the line to read except where architectural design on the development plan is approved by council.

There was no one present to speak for or against this project.

Mayor Kit Marshall closed the Public Hearing for items 4 thru 8 at 8:14 pm

Mayor Kit Marshall opened the public hearing to receive input for or against the request to amend the Zoning Ordinance, Section 23.1 Table 3 to add a "P" Permitted use for a Fire Station or similar public safety building in a C-2 Commercial District at 8:15 p.m. There was no one to speak for or against this item. Mayor Kit Marshall closed the Public Hearing at 8:15 pm

**10. Discussion and consider** approval of the request for the Conceptual Plan for a tract of land to be subdivided and named Parks of Aledo Vista Point; said tract being 132.53 acres out of John Sparger Survey, Abstract No. 1230 the Richard R. Eddleman Survey, Abstract No. 438 the James B. Carr Survey, Abstract No. 255, being a portions of Tract No. 1, Tract No. 2 and Tract No.3 as deeded to Noel R. Bailey and wife Elaine D. Bailey as referenced in Volume 1161, page 505, and as described in Volume 279, Page 416, Deed Records of Parker County, Texas.

Motion was made by Mayor Pro Tem Kimberly Hiebert seconded by Councilmember Paula Johns to approve the request for the Conceptual Plan for the tract of land that will be named Parks of Aledo Vista Point except as otherwise approved by the City Council on the Development Plan regarding the siding/masonry requirements.

Bailey and wife, Elaine D. Bailey as referenced in Volume 1161, Page 505, described in Volume 279,Page 416, Deed Records, Parker County, TX

Mayor Kit Marshall adjourned the Executive Session at 8:46 pm and reconvened the regular session of the City Council at 8:46 p.m.
