A. CALL TO ORDER:

The Planning & Zoning Commission met in regular session on Tuesday July 14, 2015 at the Aledo Community Center, 104 Robinson Court, Aledo, TX. 76008. Chairman Jim Witherow called the meeting to order at 7:00 p.m. with the following members present: Jim Witherow, Juston Stelzer, and Warren Pearson

D. REGULAR BUSINESS

1. Public Hearing - to consider input for or against a request for a zone

Change from R-1 Single Family Residential District to C-2 General Commercial District for a parcel of land known as lots 1&2, block 1, Aledo Park Subdivision, 425 FM 1187 S., Aledo, Texas.

Chairman Witherow opened the public hearing for those individuals who desired to speak for or against the zone change. No one spoke for or against the proposed change.

2. Discussion and consider making recommendation to the City Council to approve a request for a zone change from R-1 Single Family Residential District to C-2 General Commercial District for a parcel of land known as lots 1&2, block 1, Aledo Park Subdivision, 425 FM 1187 S., Aledo, Texas.

Warren Pearson made a motion to recommend to the City Council a zone change from R-1 Single Family Residential District to C-2 General Commercial District for a parcel described as lots 1&2, block 1, Aledo Park Subdivision, 425 FM 1187 S., Aledo, Texas. Motion seconded by Juston Stelzer.

Motion carried 3-0.

3. Discussion and action to approve a plat for lots 1 and 2, block 1, 425 FM 1187 S., Aledo Park Subdivision.

The applicant Dr. Joe Cannon outlined to the Commission his plan to develop the property at 425 FM 1187 S. Dr. Cannon expressed his desire to build a restaurant on lot 2 of the proposed plat. Dr. Cannon stated his desire to build retail/offices on lot 1 of the proposed plat.

Eddie Aguilar, PE, Dr. Cannon's engineer of record was introduced. Mr.

Aguilar and discussed the need for the public access easement.

Motion was made by Board member Juston Stelzer, seconded by Board

Member Warren Pearson recommending to the City Council to approve

short form plat of lots 1 and 2, block 1, Aledo Park Subdivision.

Motion carried 3-0.

4. Discussion and consider the demolition of a house in the Downtown Business District. - 317 FM 1187 North.

Stephanie Knopp with Matrix Demolition was present to answer any questions from the Board. Ms. Knopp stated her client is Mayola Lasater and that Ms. Lasater's desire is to demolish the home and clear the site. Ms. Knopp also stated the site will be leveled to where routine maintenance can be performed.

Motion was made by Board member Juston Stelzer, seconded by Board member Warren Pearson recommending to the City Council to allow for the home at 317 FM 1187 to be demolished.

Motion carried 3-0.
