The City Council will receive the information, and ask the City Manager to review the matter, or an item may be noticed on a future agenda for deliberation or action. - a. Discussion between City Council and City staff on the Draft Proposed FY24 City of Aledo Budget.
- b. Discuss and consider revoking the intent to issue certificates of obligation in the principal amount not to exceed \$2,000,000 and instruct the City Secretary to remove references thereto and take all actions necessary to cancel the issuance of the debt.
- c. Discuss and consider Ordinance 2023-184, an Ordinance amending Chapter 2, "Administration," of the Code of Ordinances by adding Article V, "Extraterritorial Jurisdiction," to provide a process for petitions for release from the City's extraterritorial jurisdiction and amending the fee schedule to provide a fee for petitions for release from the City's extraterritorial jurisdiction.

Consultation with Attorney to conduct a private consultation with the City Attorney on any legally posted agenda item, when the City Council seeks the advice of its attorney about pending or contemplated litigation, a settlement offer, or on a matter in which the duty of the attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with the provisions of Chapter 551, including the following items:
 - Potential Annexation North of Dean Ranch to I-20.
 - Dean Ranch Development Conversation.
 - *Aledo v. Seigmund* settlement and easement.
 - Impacts of Senate Bill 2038 on extraterritorial jurisdiction and CCN issues.

- b. § 551.087. <u>Deliberation regarding Economic Development Negotiations</u>. The City Council may convene in executive session to discuss or deliberate regarding commercial or financial information that the City has received from a business prospect that the City seeks to have locate, stay, or expand in or near the City and with which the City is conducting economic development negotiations; or to deliberate the offer of a financial or other incentive to a business prospect described above, including the following items:
 - Potential Annexation North of Dean Ranch to I-20.
 - Dean Ranch Development Conversation.
