- (c) **§ 551.074. Deliberation regarding Personnel Matters.** The City Council may convene in executive session to deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee; or to hear a complaint or charge against an officer or employee, including deliberation regarding the following officers or employees:

- **Candidates for Parks and Recreation Board Place 5**
- **Candidates for Parks and Recreation Board Alternate 1 & 2**
- **Candidates for Zoning Board of Adjustment Vacancy**
- **Candidate for Zoning Board of Adjustment (Hiebert position)**
