\* Typical *completeness review* times are 10 business days once submitted. Once an application has been deemed *complete*, it will then be considered "*FILED*." A *Completeness Determination Letter* will be provided along with review comments. Based on the complexity of the application, the duration of the review process may vary from the schedule above, resulting in consideration of the application at a later P&Z Commission meeting. Some review times have been adjusted to account for city holidays and closures.

\*\*Revised Submittals reflect the completion of the development review process. Any prior revision requests should be addressed and received by this date. This allows time for the required public notice to be provided prior to the P&Z Commission public hearing.

## **\*\*PRE-APPLICATION CONFERENCE\*\***

To promote a more efficient submittal and review process, it is recommended that applicants schedule a preapplication conference with development review staff prior to applying. This is a perfect opportunity to discuss project feasibility and ask questions. During the pre-application conference, staff will outline requirements and processes for the proposed project.
